Fund Raising and **Charitable Giving** activities are carried out by committees operating under the oversight of the 2nd Vice President for Community Outreach.

FUND RAISING COMMITTEE

This committee, operating under the oversight of the 2nd Vice President, with additional oversight of the Treasurer, is responsible for:

- Raising of funds for the Club's 1) charitable giving purposes and 2) other purposes deemed necessary by the Administrative Board, such as a capital campaign, building fund, facilities improvement, general operations, etc.
- Setting fund raising goals for each activity year, in cooperation with the Charitable Giving Committee and the Administrative Board.
- Planning a fund-raising calendar in collaboration with the Indoor and Outdoor Activities Directors, the Kitchen Director, and the Club Manager to ensure a well balanced calendar of events and activities.

CHARITABLE GIVING COMMITTEE

This committee, operating under the oversight of the 2nd Vice President for Community Outreach, is responsible for:

- Reviewing and make funding recommendations on all requests for charitable contributions:

- 1) making decisions, in collaboration with the Club Manager, and authorizing funding on any request up to an including a specific amount established by the Administrative Board during its annual budgeting process; and

- 2) in case of requests for amounts over the specified amount, providing written recommendations to the Administrative Board for authorization.

Recommending fund raising activities, to be carried out by the Fund-Raising Committee, to meet identified charitable funding needs.

CLUB DEPORTIVO SHARES!

Club Deportivo believes in charity. This tradition was established by the second item in the Club's MISSION statement, as included in the original Charter.

The Benefit Dinner has been an annual event since 2012. Funds raised are awarded to various groups in the Kino community, including the schools, Red Cross, and other social programs. Groups receiving donations must go through an application process, and once approved, are assigned tasks to help hold the event. This year we had 25 applicants.

The Benefit Dinner of 2025 was another successful event. This dinner raised \$350,000 MXN pesos for the **Charity Fund**. The Festival of Trees was a charity event that occurred in December 2024 and raised an additional \$50,000 MXN pesos. Right off the top, 40% of

this money went to Club Deportivo. We know that the Club must remain financially healthy to be able to give aid to the local community. The Club receives \$160,000 MXN pesos, and the charitable giving fund receives \$240,000 MXN pesos. This is all thanks to the tremendous efforts of the organizers and volunteers from both these events.

The committee feels strongly that donated funds must be used wisely and responsibly. Therefore, we monitor how benefitting groups use our donations, including requiring receipts for goods and services purchased with our donated funds. Requests are researched as best as possible. So, each group does not necessarily receive the same amount of money. We try to make sure that any available alternative funding (government programs, community resources. etc.) is used before we allocate money, so not all requests are approved.

There are many needs in this community. We strive to address these as best as possible.
